




Front View:

Instructions

Power ON/OFF

- Power ON: Press and hold the power button down for 3 to 5 seconds and then release.
- Power OFF: Press and hold the power button down for 3 to 5 seconds and then release.

SIM/SD Card Installation


- 1. Remove the back cover.
- 2. Gently remove the battery from the device.
- 3. Insert the card into the relevant card slot.
- 4. Replace the battery and back cover.

Load Printer Paper

1. When the printer is out of paper, Press the button on the left of the printer to open the cover.



2. Load the paper roll into the paper compartment and extend the end of the paper out of the printer.



3. Close the printer cover. The "out of paper" indicator light deactivates.

Magnetic Stripe Card

Insert the card into the reader slot located on the top of the Q10A. The terminal reads the information from the card when the magnetic stripe is inserted into the card slot.

IC/Smart Card Reader

Insert the card with the front facing you and the chip down into the card slot. Leave the card inserted until the terminal prompts to remove the card.

Contactless Card Reader

Tap the card to the Q10A screen or the NFC Payment Module when prompted. The terminal uses an antenna device that detects and retrieves information from the card.

CLEANING THE DEVICE

- Do not use industrial strength or abrasive cleaner as it may damage or scratch the screen.
- Do not immerse the device in water or liquid.
- Do not spray water or cleaner into EMV Card Reader or ports.
- To clean the screen, apply distilled water or mild glass cleaner onto a soft, lint-free cloth and gently wipe terminal.

TERMINAL INSTALLATION AND USAGE TIPS

- If any cables become damaged, seek a replacement.
- Do not insert unknown materials into any port on the E700m; this may cause serious damage.
- If repairs are required, please contact a professional technician instead of attempting them on your own.

- Do not vibrate, shake, or drop the device.
