

The following section provides basic operating instructions for the SK600.


#### Power ON/OFF

- **Power OFF:** Switch the power button located at the top of the terminal to the off position.


## **Printer Paper Installation**

The SK600 display will notify users when device is out of printer paper. Complete the following to load a new thermal paper roll.


1. Insert the key into the keyhole and turn it counterclockwise to open the printer cover. Completely open the printer cover.



2.	Insert	the	new	paper	roll	into	the	printer.


